1 Briefly describe the organization's mission: Explore & protect the ocean by advancing public awareness of the ocean's importance as Earth's life support system, furthering scientific knowledge of ocean systems & igniting public support for a network of MPAs--Hope Spots--Mission Blue aims to save and restore the ocean. Collectively, with the ocean community, our goal is 30% protection by 2030.

4a (Code:) (Expenses \$ 853,318 including grants of \$ 442,578) (Revenue \$) Hope Spot Program: Mission Blue designates and supports ecologically significant ocean regions known as Hope Spots to promote marine conservation and community-led protection. Hope Spots are nominated by local scientists and advocates, then supported through capacity building, communications, science tools, and partnerships that drive measurable conservation outcomes. As of 2025, the Hope Spot Network includes 167 sites across 115 countries, spanning approximately 58 million square kilometers of ocean.

4b (Code:) (Expenses \$ 532,117 including grants of \$ 133,340) (Revenue \$) The Science and Exploration Program strengthens Mission Blue's data-driven conservation work. Through partnerships with Esri, universities, and research institutions, the program uses GIS technology, environmental DNA (eDNA), and field expeditions to map biodiversity, track ocean health, and inform protection strategies. This science underpins Hope Spot designations, policy advocacy, and management planning. The program also hosts scientific workshops and supports data integration for the global Hope Spot Network.

4c (Code:) (Expenses \$ 618,058 including grants of \$ 185,000) (Revenue \$) Communications, Education, and Advocacy: Mission Blue raises global awareness of ocean conservation through storytelling, film, digital campaigns, and public events featuring Dr. Sylvia Earle and Hope Spot Champions. The organization engages millions worldwide through media partnerships, social platforms, and educational outreach to inspire behavioral change and support for marine protection. Mission Blue also participates in international policy forums such as the UN Ocean Conference and COP meetings to elevate the ocean's role in climate action.
